

Wyoming's political and fiscal environments are stable as is the CHIP population. Like many states, we currently face a budget shortfall as a result of the Public Health Emergency and declining oil and mineral industries.

2. What's the greatest challenge your CHIP program has faced in FFY 2021?

CHIP's biggest challenge continues to be our Eligibility Contractor. The Eligibility Contractor has had high staff turnover causing inconsistent eligibility determinations and frustration for clients.

Our M-CHIP program has experienced its first year throughout this FFY 2021. Our Department has met its original savings projections proposal through a combination of lower provider rates when harmonized with Medicaid and lower administrative costs. Cost savings for the program has resulted in 32% lower permember per-month costs for the program.
