Preamble

In addition, this section of the Act provides that the state must assess the progress made in reducing the number of uncovered, low-income children. The state is out of compliance with CHIP statute and regulations if the report is not submitted by January 1. The state is also out of compliance if any section of this report relevant to the state's program is incomplete.

1. What other strategies does your state use to measure and report on access to, quality, or outcomes of care received by your CHIP population? What have you found? [7500]

The Florida Healthy Kids Corporation (FHKC) contracts with an external quality review organization (EQRO) to conduct a network access validation assessment using the health and dental plans' network and enrollment. Contractual requirements with the plans were used to define time and distance requirements; however, the EQRO's assessment extended beyond the contractually specified provider types. Year-to-year comparisons will not be available because the network access requirements expanded between the previous report and this report, and FHKC updated the methodology used to determine access. The 2019 Performance Measure Validation Reports for each of the Medical Health Care plans indicates that over 90% of children and adolescents have access to Primary Care Practitioners.

FHKC's health and dental plans calculated and reported the results of performance measures specific to the Florida Healthy Kids population. FHKC's EQRO validated these results. The performance measures are nationally recognized measures and include many of the measures included in the 2019 Child Core Set. While the Florida Healthy Kids program does not provide EPSDT benefits, the dental-related measures reported in CMS-416 are relevant to the population, and so the dental plans' performance measures are primarily based upon CMS-416 dental services calculations. The dental plans were also asked to calculate a modified version of the dental sealants measure in addition to the nationally recognized version. The modified version excludes enrollees who have had molars previously sealed, restored, or extracted from the denominator. The 2019 Performance Measure Validation Report for each of the Dental Health Care plans reported at least 59% utilization of any dental service by enrollees continuously enrolled for at least 11 months during 2019.

What strategies does your CHIP program have for future measurement and reporting on access to, quality, or outcomes of care received by your CHIP population? When will data be available? [7500]

FHKC recently reprocured the health plan contracts. New contracts begin January 1, 2020. These contracts include several provisions aimed at measuring and improving quality and providing FHKC with flexibility to add specific quality intitiatives during the contract term.

FHKC is further refining the network access analysis methodology to improve function and data accuracy. Data is expected to be available by early 2021.

FHKC will have the plans report on the same list of performance measures from 2019 in 2020, including the outgoing health plans, to ensure the transition between contracts does not impact the performance measures. Beginning in 2021, the health plans will continue to report on the current performance measures in addition to all applicable measures from the 2020 child core set. "Applicable" measures is specified because FHKC's population includes enrollees ages 5 years through 18 years, which fall outside the age range for some child core set measures. Data is expected to be available in early 2022. FHKC is also retiring the well-child visit Performance Improvement Plan (PIP) for enrollees ages 5 and 6 years, effective January 2020. This PIP will be replaced with a PIP focused on improving rates for screening for depression and follow-up plan for enrollees ages 12 years to 17 years. Data is expected to be available in early 2021.

Section IIIA: Outreach

1. How have you redirected/changed your outreach strategies during the reporting period? [7500]

The Florida Healthy Kids Corporation is statutorily required to provide marketing for the entire Florida KidCare program (children's Medicaid and CHIP). The use of data analytics continues to allow the Florida KidCare program to become more targeted in its approach to outreach and advertising.

By combining available public data on the uninsured population, such as the U.S. Census, with known enrollment trends, community outreach partners can focus their work in pockets of targeted counties with the most low-income schools or community health care clinics, allowing them to connect with children most likely to need Florida KidCare coverage.

In addition to leveraging public schools in Florida to reach large pockets of low-income, uninsured children, FHKC has begun engaging and forging partnerships with children's hospitals and community clinics where these children are likely to seek care. This approach provides parents the opportunity of enrolling in coverage and creating a true medical home.

Access to this data also allows FHKC to stretch its advertising dollars to target specific audiences with an end goal of securing completed, online applications.

CHIP enrollment continues to grow steadily, offering some confidence in this approach.

2. What methods have you found most effective in reaching low-income, uninsured children (e.g., T.V., school outreach, word-of-mouth)? How have you measured effectiveness? [7500]

Paid search marketing and native display advertising, school outreach, and health care outreach. Advertising effectiveness is measured through traditional metrics, such as cost per thousand impressions, cost per thousand clicks, website visits and web application completions, etc. Outreach effectiveness is measured through unique website codes attached to collateral given away at events, which can track website visits and application start/completions. Effectiveness is also measured in the number of community outreach partner trainings completed, which expand the brand's overall outreach footprint, and number of community events worked.

Paid search marketing continues to be an effective and cost-effective advertising tool for the program, while person-to-person outreach offers an effective opportunity to overcome language and/or knowledge barriers that may impact a person's likelihood of applying.

Section V: Program Challenges and Accomplishments

1. For the reporting period, please provide an overview of your state's political and fiscal environment as it relates to health care for low income, uninsured children and families, and how this environment impacted CHIP. [7500]

The Florida Legislature remains supportive of the role CHIP plays in making affordable, quality healthcare services available to uninsured, low income children and families. From a fiscal perspective, the process includes a robust review of enrollment, projected enrollment, revenues and expenses. Specifically, the Florida KidCare Social Services Estimating Conference (SSEC) convenes several times each year. Representatives from the Executive Office of the Governor, the Florida Legislature, and the Division of Economic and Demographic Research evaluate the program's enrollment and expenditures and make recommendations for the state's annual legislative budget. Each year, the Florida Legislature considers the recommendations of the SSEC. Historically, the Florida Legislature has appropriated sufficient funds to meet the needs of the program.

2. During the reporting period, what has been the greatest challenge your program has experienced? [7500]

Florida has experienced an increase in the rate of uninsured children; increases have occurred for the most recent two reporting years.

3. During the reporting period, what accomplishments have been achieved in your program? [7500]

The Florida Healthy Kids Corporation's advocacy at the federal level helped gain support for the passage of the Bipartisan Budget Act of 2018, which included CHIP funding for 10 years through FY 2027. The Corporation's advocacy also led to the passage of a provision allowing states to have CHIP look alike, full-pay plans that are exempt from ACA requirements. During the 2019 Floridalegislative session, the Florida Healthy Kids Corporation's advocacy contributed to the passage of state funding that allowed the Florida Healthy Kids Corporation to utilize this federal authority to "combine" subsidized and full-pay risk pools. The result is full-pay children plans will have no deductibles or coinsurance, and lower copays. The expectation is this will incentivize enrollment, which could lead to an estimated increase of as many as 20,000 insured children.

4. What changes have you made or are planning to make in your CHIP program during the next fiscal year? Please comment on why the changes are planned. **[7500]**

Florida's CHIP program is subject to a \$1 million lifetime benefit maximum limit per child per Florida Statutes. The Corporation is advocating for the elimination of this lifetime limit with bills filed within the Florida Senate and House of Representatives to repeal this maximum during the 2020 legislative session.

The most significant changes to the CHIP program are pursuant to the Bipartisan Budget Act of 2018 enabling a CHIP look-a-like full pay plan which begins January 1, 2020. These changes are intended to reduce the uninsured rate of children in Florida
