



Overview of the Dental and Oral Health Services Measures in the 2024 Child Core Set

Introduction

Improving oral health outcomes for children and adolescents in Medicaid and the Children’s Health Insurance Program (CHIP) is a priority for the Centers for Medicare & Medicaid Services (CMS). Tooth decay is one of the most common chronic conditions of childhood, can have long-lasting effects on healthy growth and development, and is more prevalent among children who are from low-income families.¹

In recognition of this priority, CMS reports on quality improvement efforts and progress in this area each year.² Furthermore, the Core Set of Children’s Health Care Quality Measures for Medicaid and CHIP (Child Core Set) includes three measures that focus on measuring access to high quality and appropriate dental and oral health services (Table 1).

CMS added the Sealant Receipt on Permanent First Molars (SFM-CH) measure to the 2021 Child Core Set to replace the Dental Sealants for 6–9-Year-Old Children at Elevated Caries Risk (SEAL-CH) measure, which was retired by the measure steward. In 2022, CMS added two new measures to the Child Core Set – the Oral Evaluation, Dental Services (OEV-CH) measure and the Topical Fluoride for Children (TFL-CH) measure. These measures replaced the Percentage of Eligibles Who Received Preventive Dental Services (PDENT-CH) measure. Reporting on all three of these measures is mandatory for FFY 2024 Child Core Set reporting.³

States must ensure that all measure-eligible Medicaid and CHIP beneficiaries are included in state reporting.⁴ This includes beneficiaries who moved in or out of a program (Medicaid or CHIP), who were enrolled in more than one managed care plan, or who changed delivery systems (fee-for-service, managed care, primary care case management) during the measurement period, as long as the beneficiary meets the measure’s continuous enrollment requirement at the state level.

Taken together, the measures focus on an overall oral evaluation (OEV-CH) and two evidence-based preventive services (TFL-CH and SFM-CH). They will support CMS and states in continuing to improve dental and oral health among Medicaid and CHIP beneficiaries. This technical assistance resource provides an overview of the three dental and oral health services measures in the 2024 Child Core Set, and highlights differences in the measure specifications (Table 2).

Oral Evaluation, Dental Services (OEV-CH)

The Oral Evaluation, Dental Services (OEV-CH) measure examines the percentage of enrolled children under age 21 who received a comprehensive or periodic oral evaluation within the measurement year. This measure includes one rate that measures the number of children who received an oral evaluation as a dental service during the measurement year. This measure uses the CDT⁵ codes and the NUCC maintained coding system to determine the numerator.

Claims with missing or invalid CDT codes, missing or invalid NUCC maintained Provider Taxonomy Codes, or NUCC maintained Provider Taxonomy Codes that are not listed in the measure specifications will not be counted in the numerator.

For the 2024 Child Core Set, the measure steward updated the technical specifications for the OEV-CH measure, which includes the following:

- Added Guidance for Reporting to clarify which rates are subject to mandatory reporting:
 - For FFY 2024 Child Core Set reporting, the following rate is required: Total ages <1 to 20.
- Clarified in the numerator that the oral evaluation must be “comprehensive or periodic.”
- Clarified data quality considerations.
- Updated the link to the DQA Measures User Guide in the Additional Notes section.

Topical Fluoride for Children (TFL-CH)

The Topical Fluoride for Children (TFL-CH) measure examines the percentage of enrolled children ages 1 through 20 who received at least two topical fluoride applications as (1) dental or oral health services, (2) dental services, and (3) oral health services within the measurement year, where there were at least two unique dates of service when topical fluoride was provided. This measure includes three rates: (1) dental or oral

health services, (2) dental services, and (3) oral health services.

This measure uses the CDT, CPT, and NUCC coding systems to determine the numerator: the rate for dental or oral health services (Rate 1) uses CDT and CPT codes. The rate for dental services (Rate 2) and the rate for oral health services (Rate 3) use CDT codes and NUCC maintained Provider Taxonomy Codes to determine the numerator. Rate 3 also uses CPT codes.

The technical specifications for the TFL-CH measure describe additional factors to consider when determining the numerator of each rate, which include the following:

- The numerator of Rate 1 is not the sum of the numerators of Rates 2 and 3. There may be cases where a child may be eligible to be included in the numerator of Rate 1, but not in the numerators of Rates 2 and 3. There may also be a case where a child could be eligible to be included in the numerators of both Rates 2 and 3.
- The numerator cannot include more than one fluoride application per beneficiary on the same date of service. This applies to all three rates.
- All claims that have missing or invalid service codes (CPT and CDT codes) should be excluded from the numerator. This applies to all three rates.
- All claims that have missing or invalid NUCC maintained Provider Taxonomy Codes should be excluded from the numerator. This applies to Rates 2 and 3.

All modes of topical fluoride application (all CDT and CPT codes for this measure) are considered equally effective for this measure. This measure does not consider alternate home-use fluoride products including supplements.

For the 2024 Child Core Set, the measure steward updated the technical specifications for the TFL-CH measure, which includes the following:

- Added Guidance for Reporting to clarify which rates are subject to mandatory reporting:

- For FFY 2024 Child Core Set reporting, the following three rates are required: (1) Dental or oral health services: Total ages 1 through 20; (2) Dental services: Total ages 1 through 20; and (3) Oral health services: Total ages 1 through 20.
- Clarified data quality considerations.
- Updated the link to the DQA Measures User Guide in the Additional Notes section.

Sealant Receipt on Permanent First Molars (SFM-CH)

The Sealant Receipt on Permanent First Molars (SFM-CH) measure examines the percentage of enrolled children who have ever received sealants on permanent first molar teeth for (1) at least one sealant and (2) all four molars sealed by the 10th birthdate. This measure includes two rates: (1) sealant for at least one permanent first molar, and (2) sealants for all four molars. This measure uses CDT codes, tooth number codes, and surface codes to determine the numerator and exclusions. A record with a missing or invalid tooth number code may not be counted in the numerator.

For the 2024 Child Core Set, the measure steward updated the technical specifications for the SFM-CH measure, which includes the following:

- Updated the link to the DQA Measures User Guide in the Additional Notes section.
- Updated the “Exclusions” section to clarify that a beneficiary is excluded if they have a restorative code that includes occlusal tooth surface alone OR in combination with any other surface codes.
