Dear Ms. Cummings:

This is to inform you that the title XXI Children's Health Insurance Program (CHIP) State plan amendment (SPA) submitted April 2, 2009, with additional information submitted on October 22, 2009, and January 11, 2010, has been approved.

This amendment establishes a dental benefit cap (effective February 1, 2009); modifies vision benefits (effective February 1, 2009); and increases premiums (effective February 1, 2009). Additionally, this SPA establishes an infrastructure for a waiting list and enrollment cap (effective January 31, 2009); eliminates the AIM program's 6-month residency requirement (effective January 6, 2009); and modifies notification procedures related to the premium grace period (effective February 1, 2009).

As we previously discussed with you, this current SPA does not satisfy the statutory requirements of section 501(b) of the Children's Health Insurance Program Reauthorization Act of 2009 (CHIPRA). However, it is our understanding that the State will be working through this upcoming legislative session to ensure that the dental benefits provided through the State plan meet the statutory requirements of section 501(b) of CHIPRA. The Centers for Medicare & Medicaid Services continues to be available, should you need technical assistance.
