I am pleased to inform you that your Children's Health Insurance Program (CHIP) state plan amendment (SPA) number MD-14-0010, submitted on June 17, 2014, and related to Modified Adjusted Gross Income (MAGI) Eligibility, has been approved with an effective date of January 1, 2014.
