Your fifteenth title XXI Children's Health Insurance Program (CHIP) State plan amendment (SPA) submitted on March 29, 2010, with revised State plan pages and additional information submitted on June 23 and June 28, 2010, has been approved. This amendment has a retroactive effective date of April 1, 2009.

This SPA includes changes that New York has made to its title XXI program during the past State fiscal year, April 1, 2009 through March 31, 2010, in order to demonstrate compliance with sections 502, 503, and 504 of the Children's Health Insurance Program Reauthorization Act of 2009 (CHIPRA). Specifically, these changes include the following: (1) removal of coverage limits for inpatient and outpatient mental health and substance abuse services in order to meet the requirements for mental health parity; (2) reimbursement of federally-qualified health centers (FQHCs) and rural health clinics (RHCs) using a prospective payment system (PPS) methodology; and (3) clarification regarding implementation of the premium grace period. In addition, the SPA makes minor programmatic updates regarding the application form and outreach activities.

In accordance with section 503 of CHIPRA, New York is implementing its PPS reimbursement methodology for FQHCs and RHCs retroactive to October 1, 2009.
