Your sixteenth title XXI Children's Health Insurance Program (CHIP) State plan amendment (SPA) submitted on March 21, 2011, has been approved. This SPA implements an electronic data match with the Social Security Administration (SSA) in order to fulfill the citizenship documentation requirements of Section 211 of the Children's Health Insurance Reauthorization Act of 2009 (CHIPRA) and also incorporates revisions to the template for coverage of lawfully residing children.

The implementation of the SSA data match option has a retroactive effective date of October 1, 2010, and the revisions related to coverage of lawfully residing children have a retroactive effective date of April 1, 2010.

The State had previously received approval for coverage of lawfully residing children under SPA #13, with a retroactive effective date of April 1, 2009. After the approval of SPA #13, on July 1, 2010, the Centers for Medicare & Medicaid Services (CMS) issued further guidance and a template included groups eligible for coverage under section 214 that were not previously included. In response to a request from CMS, New York submitted this SPA in order to include the groups in the July 1, 2010 template. The State has confirmed that it always intended its State Plan to conform with the direction of the July 1, 2010 guidance.
