The State is seeking a federal match on funds received from the Robert Wood Johnson Foundation (RWJ) grant, Maximizing Enrollment for Kids: Making Medicaid and SCHIP Work. The grant was awarded to the State on February 11, 2009 and the grant period is from February 15, 2009 through February 14, 2013. The State's initiative is entitled *Working Smart for Utah's Kids.*

The State was granted a total of \$999,934 and below is a summary of general grant functions. RWJ will conduct a diagnostic assessment and improvement plan. The final budget is subject to approval from the RWJ National Program Office and will be based on the results of the diagnostic assessment.

Working Smart for Utah's Kids seeks to maximize enrollment of eligible Utah children by removing administrative barriers to enrollment and retention. Working Smart plans to achieve this goal by implementing four specific objectives: (1) Streamline the Application Process (2) Simplify Renewal Process and Improve Client Education (3) Integrate School Data from Free and Reduced School Lunch Program and (4) Evaluate Multicultural Outreach to Develop Best Practices.

The State assures that RWJ has <u>less</u> than 25% in annual revenue generated from health care providers and that RWJ does not provide services (including administrative) directly or indirectly under the Medicaid or SCHIP state plan.
