

Limitation of Services

6. Medical care and any other type of remedial care recognized under State law, furnished by licensed practitioners within the scope of their practice as defined by State law.(Continued).

Effective Date: 10/01/94

(2) Neonatal Nurse Practitioner Services: Providers in this program are limited Registered Nurses who are also certified as neonatal nurse practitioners.

(3) A nurse practitioner who is employed and reimbursed by a facility that receives reimbursement from Alabama Medicaid Program for services provided by the nurse practitioner shall not bill separately since these services are included in the reimbursement made to that facility through their cost report (i.e., hospitals, FQHC's, rural health clinics, etc.).

Effective Date: 01/01/98

(3) A nurse practitioner who is employed and reimbursed by a facility that receives reimbursement from Alabama Medicaid Program for services provided by the nurse practitioner shall not bill separately since these services are included in the reimbursement made to that facility through their cost report (i.e., hospitals, rural health clinics, etc.).

Effective Date: 04/01/98

(4) Nonphysician Practitioner Services: Medicaid payment may be made for professional services to the following physician-employed practitioners:

Physician Assistants(PA)

Certified Registered Nurse Practitioners (CRNPs)

The Alabama Medicaid Agency will make payment for services of PAs and CRNPs who are legally authorized to furnish services and who render the services under the supervision of an employing physician with payment made to the employing physician.

(5) Pharmacists: The Alabama Medicaid Agency will make payment for the administration of vaccine by a pharmacist who is employed by a pharmacy participating in the Alabama Medicaid Program.

In order to establish the rates for teaching physicians, the rates paid by the top five commercial insurance companies in Alabama were obtained. The State calculated the average commercial rate for each procedure code and determined the total expenditures the State would have made during a twelve-month period using the average rates. Then the State calculated total expenditures the State would have made during the same period using rates equal to 134.5% of Medicare rates. Since total expenditures using 134.5% of Medicare were less than the expenditures using the average commercial rates, the State will pay enhanced rates equal to 134.5% of Medicare to teaching physicians. Calculated reimbursement rates for all numeric procedure codes will be rounded to the nearest dollar. Rates for procedure codes starting with an alphabetic character will be rounded to the nearest penny. Procedure codes not recognized by Medicare are ineligible for the enhanced payment.

Effective Date: 07/01/87

- c. Medicaid recipients are required to pay and providers are required to collect designated copayments for services, supplies, appliances, and equipment, except for the designated exemptions. The allowable copayment amount shall be credited against the Medicaid payment to the providers according to the copayment table in Attachment 4.18-A. Designated exemptions include services provided for pregnancy, nursing home residents, inpatient hospital visits, recipients under 18 years of age, emergencies, surgery fees, physical therapy, and family planning.

Effective Date: 06/01/90

- d. Payment to Certified Registered Nurse Anesthetists will not exceed 85% of the maximum allowable rate paid to physicians for providing the same service.

Effective Date: 04/01/98

- e. Payment to physician-employed Physician Assistants and Certified Registered Nurse Practitioners will not exceed 85% of the maximum allowable rate paid to physicians for providing the same service except for injectables and laboratory procedure. Injectable and Laboratory procedures are reimbursed at 100% of the amount paid to physicians.

Effective Date: 11/02/09

- f. Pharmacists, employed by pharmacies participating in the Alabama Medicaid program, are reimbursed a vaccine administration fee established at the same rate paid to physicians. The Agency's rate for vaccine administration was set as of January 1, 1999, and is effective for services on or after that date. All rates are published on the Agency's website. Except as otherwise noted in the plan, state developed rates are the same for both governmental and private providers.
