Continuous Eligibility for Children A child under age 19 (not to exceed age 19) who has been determined eligible under 1902(a)(10)(A) of the Act is deemed to be eligible for a total of 12 months (not to exceed 12 months) regardless of changes in circumstances, other than moving out of state or attainment of maximum age stated above, until the earlier of: a. The end of a period (not to exceed 12 months) of continuous eligibility; or b. The time that the individual exceeds that age.

Presumptive Eligibility for Children</p> <p data-bbox="708 623 1376 819">Children under age 19 (no more than 19) who are determined by a "qualified entity" (as defined in section 1920A(b)(3)(A)) based on preliminary information, to meet the highest applicable income criteria specified in this plan under ATTACHMENT 2.6-A and are therefore determined to be presumptively eligible during a presumptive eligibility period in accordance with 1920A of the Act.</p> <p data-bbox="708 848 1376 1125">The presumptive period begins on the day that the determination is made. If an application for Medicaid is filed on the child's behalf by the last day of the month following the month in which the determination of presumptive eligibility was made, the presumptive period ends on the day the state agency makes a determination of eligibility based on that application.
