RHC services also include services and supplies that are furnished as incident to professional services furnished by a physician, physician assistant, nurse practitioner, nurse midwife, clinical psychologist or clinical social worker and, for visiting nurse care, related medical supplies other than drugs and biologicals. Other ambulatory services are services provided by podiatrists, optometrists, audiologists, dentists, dental hygienists, chiropractors, licensed professional counselors, licensed marriage and family therapists, physical therapists, occupational therapists and speech-language pathologists.
