We have reviewed West Virginia State Plan Amendment (SPA) 10-07, which provides that medical assistance for Medicare cost sharing is protected from estate recovery for beneficiaries eligible under the Medicare Savings Programs (MSP). This exemption only affects beneficiaries eligible for the MSP, who are age 55 and over and who receive nursing home services, home and community-based services, and related hospital and prescription drug services.

Enclosed is a copy of the approved SPA and signed CMS-179. The SPA is effective for dates of service on or after January 1, 2011.

## 4.17 (b) Adjustments or Recoveries

(3) (Continued)

Limitations on Estate Recovery - Medicare Cost Sharing:

- (i) Medical assistance for Medicare cost sharing is protected from estate recovery for the following categories of dual eligibles: QMB, SLMB, QI, QDWI, QMB+, SLMB+. This protection extends to medical assistance for four Medicare cost sharing benefits: (Part A and B premiums, deductibles, coinsurance, copayments) with dates of service on or after January 1,2010. The date of service for deductibles, coinsurance, and co-payments is the date the request for payment is received by the State Medicaid Agency. The date of service for premiums is the date the State Medicaid Agency paid the premium.
- (ii) In addition to being a qualified dual eligible the individual must also be age 55 or over. The above protection from estate recovery for Medicare cost sharing benefits (premiums, deductibles, coinsurance, co-payments) applies to approved mandatory (i.e., nursing facility, home and community-based services, and related prescription drugs and hospital services) as well as optional Medicaid services identified in the State plan, which are applicable to the categories of duals referenced above.
