REMITTANCE ADVICE REPORT (RAR) IMPLEMENTATION WORKGROUP

The RAR implementation workgroup met in Baltimore on June 20-21. Ongoing conference calls will be used to facilitate the completion of the workgroup's assignments no later than September 30. The workgroup's main activities include revising the RAR format to resolve implementation problems, revising and clarifying the prior period adjustment process, and standardizing the State submittal of utilization changes to labelers.

One area of the RAR workgroup discussions involved the adjustment and dispute codes, and the use of codes currently not contained on the RAR. In an effort to provide States with the most comprehensive explanation of adjustments and disputes, the workgroup is considering expanding the lists of these codes.
