VINCE POWELL RETIRES

After 32 years of Federal service, Vince is retiring effective January 3, 2006. Vince has been with the Drug Rebate Program since its inception in 1990 and was instrumental in implementing the operational aspects of the program. After many years of serving as the lead analyst for drug rebate operations, Vince became the Technical Director of the program and has served in that capacity for the remainder of his career. In addition to his operational and Technical Director duties, Vince played an integral part in the Dispute Resolution Program for many years.

Vince asked that his appreciation for the many great working relationships developed over these years be acknowledged.

<u>REPORTING PRODUCTS HAVING "INNER" AND "OUTER" NDC</u> <u>NUMBERS</u>

We have been receiving some questions on how labelers should report the Units Per Package Size (UPPS) for "inner" NDCs (the NDCs of individual packages within an overall container) versus "outer" NDCs (the NDCs of the overall containers which hold the individual packages) for purposes of the drug rebate program. For drugs that have inner and outer NDCs, the "inner" NDCs (e.g., a bottle of tablets, a tube of cream, etc...) have the same product code (NDC1 and NDC2) as the "outer" NDCs (e.g., a box of 24 bottles of tablets, a case of 48 tubes of cream, etc...), but have different package size codes (NDC3). When this happens, the product may be dispensed either by the overall container or by the individual package; however, the "inner" and "outer" NDCs will each have different UPPS values. As a reminder, the UPPS is either reported Page 2 – Medicaid Drug Rebate Program

as "1" where packages can be broken down and individual units (i.e., TAB, CAP, TDP) dispensed or as the total number of units contained in an unbreakable package. The UPPS of an "outer" NDC is always equal to the total number of units in the package.

For example, if an "inner" NDC represents a bottle of 100 tablets that can be broken down and dispensed per tablet, and an "outer" NDC represents a case of 24 bottles with 100 tablets in each bottle that cannot be broken down, the UPPS for each NDC would be as follows:

NDC of "inner" bottle = UPPS of "1" NDC of "outer" case of 24 bottles = UPPS of "2400" (24 x 100 = 2400)

If, in the above example, the "inner" NDC represents a bottle of 100 that cannot be broken down for individual tablet dispensing, then the UPPS would be "100" for that NDC. In either case, however, pricing (AMP/BP) is always the value of one unit (i.e., TAB, ML, TDP, etc...) regardless of whether it is dispensed by the "inner" or "outer" NDC.

UPDATES TO THE OPERATIONAL TRAINING GUIDE

Pages O2 and O4 are revised to remove Vince Powell as an operational staff member and, as appropriate, substitute other operational staff. Page O5 is updated to change the contact for region VII and to correct the exclusion of Utah in Region VIII.
