TERMINATIONS

Xactdose, Incorporated (Labeler Code 50962) apparently requested termination in a letter to HCFA dated April 25, 1991 and again in a letter dated September 30, 1991. We are honoring the April request and are advising Xactdose that their rebate agreement is terminated effective July 1, 1991. They are aware that they are responsible for providing rebates for the first two calendar quarters. Due to the lateness of this notice, FFP will be available for claims paid through December 31, 1991 for this labeler code. If you have not already done so, do not invoice this company for claims paid after June 30, 1991.

Med-Care, Incorporated (Labeler Code 49452), located in Jamestown, Tennessee, is being involuntarily terminated since they do not possess a valid labeler code issued by the FDA. Their two drug products are liquid versions of solids marketed by the Spectrum Chemical Manufacturing Corporation located in Gardena, California. The two drugs being marketed by Med-Care are Albuterol (NDC 49452-0225-02) and Metaproteronol (NDC 49452-4555-02). Due to the lateness of this notice, FFP will be available for claims paid on Labeler Code 49452 from October 1 through December 31. DO NOT INVOICE EITHER COMPANY FOR CLAIMS PAID BEFORE JANUARY 1, 1992. However, you can invoice Spectrum Chemical Manufacturing Corporation for claims with a service date on or after January 1, 1992.
