MANUFACTURER NAME AND ADDRESS CONTACT INFORMATION DISKETTE

Enclosed is a diskette with the latest version of drug labeler names, addresses and telephone numbers of the legal, financial and technical contacts. All information is current as of January 20, 1993. This diskette, as usual, contains two files. The first is called LABCONT.RPT and is in a report format that can be read and printed by using WordPerfect. The second is called LABCONT.TXT and is a "flat" file that can be used in text format.

We expect this to be the last time we will need to send this information on individual diskettes. Effective with the quarterly update for 93-1, we will include a separate, updated file on the tape/cartridge each and every quarter. The name of this file will be:

The data set can be downloaded as a print file from your mainframe. The record layout is attached.
