OVERPAYMENTS DUE TO AVERAGE MANUFACTURER PRICE (AMP) RECALCULATIONS

As a result of recalculations of its AMPs and our review of those recalculations, The G.D. Searle Company (labeler codes 00014, 00025, and 00905) has submitted revised AMPs for the first quarter of 1991 through the first quarter of 1995, and will be recovering overpayments from States for excessive rebates paid during those quarters. These recalculations are necessary since the company had failed to properly compute AMP for pricing data prior to the second quarter 1995. In many States, these recalculations resulted in significant overpayments.

Beginning with third quarter 1995 invoices, and on a State-by-State basis, Searle will begin recoupment of the overpayments from current and subsequent quarterly rebates (if necessary) until the overpayments have been recovered. Searle has indicated that it will contact each State representative to inform you of this action and has expressed a willingness to work with individual States to recover the overpayments over several quarters, if necessary, to minimize financial hardship. In the meanwhile, States should continue to invoice Searle for current quarters as usual.

Although we have authorized Searle to revise its AMPs and begin recoupment of overpayments based on the reduced unit rebate amounts, there is an audit of Searle's AMPs underway by the Office of the Inspector General. If the audit reveals that the revised AMPs are unacceptable and that the overpayments were overstated, we will require the company to repay any amounts due the States.

HCFA CLOSURE DURING FEDERAL FURLOUGHS

HCFA was included in the recent closure of several Agencies of the Federal Government due to the Congressional/White House budget stalemate. During this period the majority of HCFA personnel were furloughed, NOT on duty and, therefore, unable to answer telephone calls or return messages.

REPORTING UTILIZATION CHANGES TO LABELERS

In Release Number 53, dated August 16, 1995, States were asked to inform labelers of the method used to submit utilization changes, i.e., either overlay or +/-. The purpose of this request was to assist labelers in expediting the review and processing of invoices.

To date, only a handful of States have informed labelers of the State's method of reporting unit changes. To simplify your response to labelers, attached is a short form which you can either submit with your next invoice or send separately. Please take a minute to complete the form to help avoid any future confusion in labelers' reviews of unit changes. This form is a one-time submittal to labelers, unless you change your method of reporting utilization changes.

INFORMATION SHARING

HCFA drug rebate staff often receives calls requesting information on subject matters already covered in State releases. (We are not referring to calls requesting clarification of release items.) The major requests are: where do I send something and who do I call for . . . ? We have determined that this problem occurs primarily because information in the releases is not being shared with all personnel responsible for the drug rebate program in your State. Unfortunately, HCFA can accommodate only one name per State (in addition to the State Medicaid Director) to receive releases. Therefore, it is important that you share the releases, or specific release items, with those in your State who are responsible for the subject matters at hand. In particular, if you have not already done so, please share release number 53, which lists HCFA's drug rebate staff/phone numbers.

Your cooperation in this matter is appreciated and will assist everyone in better managing their time and workloads.

ADDITIONAL ADJUSTMENT CODE FOR FORMS HCFA-304 AND HCFA-304a

In release number 56 we provided, for your information, draft copies of the Reconciliation of State Invoice (ROSI), Form-304, and the Prior Quarter Adjustment Statement, Form-304a. These forms were developed for labelers' responses to State invoices. Appendix C to these forms lists adjustment/dispute codes. This is to inform you that we are adding an adjustment code "I" to that list. This code will read, "Rebate per unit amount adjusted through correspondence between labeler/State. USE THIS CODE ONLY in instances where the State has reported a rebate per unit that does not reflect an amount based on pricing data reported by the labeler, and adjustment code A is not applicable."

This adjustment code is being added at the request of labelers who are receiving invoices containing rebate per unit amounts that do not reflect any pricing data reported to HCFA. Adjustment code I is being incorporated in HCFA's request to the Office of Management and Budget (OMB) for approval of forms 304 and 304a.

Due to the revised process for requesting OMB form approval and the recent government shutdown affecting HCFA, we do not expect OMB approval of forms 304 and 304a before April 30. Once OMB approval is received, HCFA will determine the implementation period necessary for these forms. However, we will not require labelers to implement sooner than one quarter after approval. Please keep in mind that labelers may begin using these forms voluntarily anytime before OMB approval.

LABELER CODE CORRECTION

HealthPoint Medical (a division of DPT Laboratories) submitted the wrong labeler code (00640) with their drug rebate agreement. HCFA records now show labeler code 00064 as the correct identification for HealthPoint Medical. This company anticipates launching its first drug product in January. Please change your identification for this company to reflect the corrected labeler code.
