#### DRUG REBATE DISPUTE RESOLUTION MEETINGS BEGIN IN DENVER

The Drug Rebate staff recently began the expansion of the Dispute Resolution Pilot (DRP) to the Western Consortium in the Denver Regional Office (RO). The first series of meetings involved eight States and four drug manufacturers, and resolved approximately \$8 million in rebates formerly under dispute. Additionally, staff were able to facilitate the successful resolution of a particularly sensitive situation between a State and a major drug manufacturer which had been previously stalemated. The participating States and manufacturers unanimously expressed support for the DRP and for HCFA's proactive involvement in dispute resolution under the Medicaid drug rebate program. The Drug Rebate staff will conduct another series of meetings in September, and the DRP is planned to continue through 1997. The expectation is to involve as many Western Consortium States as possible. To that end, we encourage all State Medicaid Directors to consider the value and cost-effectiveness of sending the appropriate staff to future dispute resolution meetings.

The DRP was initially conducted in the Boston RO during 1995 and early 1996. In September, the Medicaid Bureau and Region I coordinators of the DRP plan to wrap-up the Region I pilot, and submit a report to the Administrator on the pilot results. The DRP in Region I resulted in the resolution of millions of dollars formerly in dispute among the six Region I States and approximately thirty drug manufacturers. The results of the first meetings in Denver indicate that similar results can be expected from the Western Consortium efforts. Hopefully, the various State Medicaid programs will be able to allocate funds to their staff so that they will be able to attend future DRP meetings in their localities.
