RECALCULATION OF OLD QUARTERS CAUSING ADDITIONAL PRIOR PERIOD ADJUSTMENTS (PPA)

You have been getting notices in past releases about changes we are doing to the MDRI process which have caused some additional PPA records to be generated. One problem we have had for a long time is the one where our Unit Rebate Amount (URA) does not calculate out to the same exact amount as those calculated by the labelers. URA values were off by anywhere from millionths of a cent to several thousandths of a cent. We found that the calculation performed by our system used floating-point decimal calculations rather than fixed-point, calculating to 7 and rounding to 6 places at the conclusion of the calculation. This has been fixed.

For this quarter, we have turned on the URA flag for EVERY NDC FOR EVERY QUARTER. This may cause an "excess" of PPA records on this run. Please understand that this is solely for the purpose of "realigning" URAs to assist you in closing out old "disputes" that had amounts in dispute simply because our URA did not match the labeler's URA. Although this may cause some additional work on your part this quarter, it is anticipated that it will close out 90 - 95% of URA problems between you and the labelers. Y2K REMINDER FOR RECORD SPECIFICATIONS

This is a reminder that the new utilization record layout is required for all data submitted beginning January 1, 1999. In release number 72, dated December 9, 1997 we attached the new record specifications to expand all date fields to allow for a four position year. The release specified that these expanded date fields would be required for all data submitted to HCFA on January 1, 1999 or later.

For your convenience, we are again attaching the utilization record format. Also, please review the utilization reporting instructions located on pages F20-F25 of the Medicaid Drug Rebate Operational Training Guide to ensure the use of the proper naming convention for utilization tapes and cartridges.
