# **TODAY'S NEWS for State Medicaid Directors**

## REVISITING 4TH QUARTER PRIOR PERIOD ADJUSTMENT (PPA) ISSUE

In release #87, dated February 9, 1999, you were told about the large number of "old" PPA records you would be seeing on the 4th quarter URA tape. These were for the purpose of URA realignment ONLY. We understand that many states opened these old quarters and included very small adjustments on invoices because of this. First, please remember that PPAs are NEVER supposed to be used to make adjustments on your invoices. Second, these were to assist you in closing out old, very small outstanding amount issues, due to rounding differences between HCFA and the labelers. Therefore, any URA amounts on your files where the HCFA and labeler URAs match up to the 4th decimal place but are different beyond that, should be closed out; do NOT send PPA FYI records to the labelers.

Again, the purpose of this exercise was to eliminate old differences between URAs reported by HCFA and those included on your payment from labelers where there was a very small (thousandths or tens of thousands of a cent) difference due to rounding while performing the rebate amount calculation. It seems that HCFA was using a floating-point decimal calculation, where the labelers were using the "calculate to 7; round to 6" rule we established at the start of the program. By changing our calculation to match that of the labelers, it was felt that most outstanding URA differences on States' files would be closed out. Therefore, HCFA will NOT be doing any more adjustments.

Note: When many of the larger labelers realized that our calculation was slightly different from theirs, they changed their calculation to match ours (2 wrongs to make a right!!). We have informed labelers that they should not have made any corrections to their URA calculation method.

#### **USING FIRST DATABANK DATA**

It continues to be a concern that many states STILL rely on First DataBank to supply HCFA data to them. Any information regarding MDRI quarterly Baseline data should be taken directly from the HCFA tape, NOT from First DataBank files. There is no drug rebate data maintained by First DataBank that is not available from the quarterly URA tapes. Remember, it is the data supplied on the HCFA file that we support. If you get data (e.g. DESI codes, Unit Types) from other sources that does not match ours, you will be responsible for payment/nonpayment inappropriately made by you to the pharmacy.
