# OVERPAYMENTS DUE TO AVERAGE MANUFACTURER PRICE (AMP) RECALCULATIONS

As a result of recalculations of its AMP and our review of those recalculations, Astra Zeneca Pharmaceuticals, for the former Zeneca Pharmaceuticals, labeler codes 00038 and 00310 will submit revised AMPs for the first quarter 1991 through fourth quarter 1999, and will be recovering overpayments from states for excessive rebates paid during those quarters. These recalculations are necessary since the company had failed to properly compute AMP for pricing data prior to the first quarter 2000. In many states, these recalculations resulted in significant overpayments.

Beginning with second quarter 2002 invoices, and on a state-by-state basis, Astra Zeneca will begin recoupment of the overpayments from current and subsequent quarterly rebates (if necessary) until the overpayments have been recovered. Astra Zeneca has indicated that it will contact state representatives to inform them of this action and has expressed a willingness to work with individual states to recover the overpayments over several quarters, if necessary, to minimize financial hardship. During the recoupment process, states should continue to invoice Astra Zeneca as usual.
