RESCISSION OF LABELER TERMINATION

By overnight fax and in State Medicaid Directors' release # 127, you were informed that labeler # 00168, E. Fougera, would be terminated from the Drug Rebate Program as of January 1, 2004. Subsequent to that release, the labeler has assured us that all invoices from quarters 1 & 2/2003 have been processed and paid. They have also supplied us with all missing pricing data.

Because E. Fougera has paid their invoices and submitted their missing data and because it would be a tremendous burden on states to not have this labeler's drugs covered, we are rescinding our termination action. Please disregard our earlier notice of their termination.

AMENDMENTS TO BEST PRICE UNDER THE MEDICARE PRESCRIPTION DRUG, IMPROVEMENT, AND MODERNIZATION ACT OF 2003 ENACTED DECEMBER 8, 2003

Discount Card Program

The Medicare Prescription Drug, Improvement, and Modernization Act of 2003 (MPDIMA) establishes a Medicare Prescription Drug Discount Card and Transitional Assistance Program at section 1860D-31 of the Social Security Act (the Act). The discount card program must begin no later than June 8, 2004. Under the discount card program, drug card sponsors will negotiate discounted drug prices with drug manufacturers on behalf of Medicare

beneficiaries using the card. Section 103(e)(1) of MPDIMA amends section 1927(c)(1)(C)(i) of the Act by adding an exemption to best price in a new subclause (V). Under subclause (V), prices negotiated with drug manufacturers for covered discount card drugs under an endorsed discount card program under section 1860D-31 of the Act are exempt from best price. Negotiated prices take into account negotiated price concessions, such as discounts, direct or indirect subsidies, and direct or indirect remunerations, for covered part D drugs. Due to the temporary nature of the discount card program, which will be replaced by the new Medicare part D drug benefit in January 2006, this best price exemption will apply for a limited time.

Medicare Part D Drug Benefit

The MPDIMA also establishes a voluntary prescription drug benefit for Medicare beneficiaries as of January 1, 2006. Section 103(e)(1) of MPDIMA also amends section 1927(c)(1)(C)(i) of the Act by adding an exemption to best price in a new subclause (VI). Under subclause (VI), any prices charged which are negotiated by a prescription drug plan under part D of title XVIII, by a Medicare Advantage plan that provides qualified prescription drug coverage, or by a qualified retiree prescription drug plan (as defined in section 1860D-22(a)(2)) with respect to such drugs on behalf of individuals entitled to benefits under part A or enrolled under part B of title XVIII are exempt from best price. This exemption shall apply to prices charged for drugs dispensed on or after January 1, 2006.

LABELER NAME & ADDRESS CHANGES

We received an e-mail from a labeler that had erroneously sent letters to all state agencies, instructing them to change the name and address of the Technical contact for that labeler. Some states made this change.

This is to remind you that the current labeler name and address file is sent as the second file on the quarterly cartridge along with the URA file from CMS. This is the official updated name and address file and is the only one you should use for dealing with the labelers. You should not accept contact changes directly from any labeler. Please use the official CMS name and address file ONLY.
