a. Occupational Therapy - State-developed fee schedule rates are the same for both governmental and private providers. The agency's fee schedule rates were set as of November 1, 2021 and were effective for services provided on or after that date. The following methodology is used to determined rates for orthotics devices when done as part Occupational Therapy Services:

The lowest of:

- 1. 85% of the 2011 Medicare fee schedule or 85% of the rate in the year Medicare assigned a rate to that code;
- 2. Medicare's allowable amount; or
- 3. The provider's usual and customary charge
